
THE IALF ANNUAL FUND

Contributions to the IALF Annual Fund are used for general operational support to fund the activities of the current leadership class. Those contributing to this fund include corporations and associations, as well as individuals such as IALF program graduates and friends of the Foundation.

Total Annual Fund investments received in FY 2017 = \$588,808

Corporations and associations accounted for 62% of annual fund contributions. Alumni and Individuals contributed 11%, Special Events accounted for 11%, Participation Fees made up 15%, and Advanced Leadership activities comprised 1% of the annual fund in FY 2017.


